Activity Report May - Nov 2024

European Parliament 2024 Elections:

- Developed a dedicated **Elections Webpage** for streamlined access to resources;
- Published an MEP Candidates Pledge to promote victims' rights;
- Released a Victims' Rights Toolkit and a Safety Tipsheet to support condidates and the public.

Exchanges and engagement with EU Institutions:

- Sent Welcome Letters to key EU Officials, including the Presidents of the Commission, Parliament, and EESC;
- Developed a **briefing for MEPs, pledge signers and political advisors**, on victims' rights in the EU and VSE Priorities;
- Monitoring of updates on EU Victims' Rights Legislative files;
- Exchanges with **Justice and Home Affairs (JHA)** officials from the Netherlands, Hungary, Germany, Spain, Ireland and Estonia in regards to the ongoing Revision of the 2012 Victims' Rights Directive (VRD);
- Participated in target consultations with MEPs and a Greens/EFA LIBE Members Networking and Strategic Meeting;
- Publication of a Joint Statement with EU NGOs following the publication of the Council's General Approach on the VRD Revision.







Activity Report May - Nov 2024

Engagement on Child Victims' Protection files:

- Membership Children's Rights Action Group (CRAG);
- Engaged in target consultations on the Recast Directive of Child Sexual Abuse with MEPs Saskia Bricmont and Isabel Serra;
- Released a **Briefing** on the ongoing revision of the **EU Child Sexual Abuse Directive (CSA)**;
- Intervention on the **Right of child victims to compensation** in the ECLAG Workshop on the Recast Directive of Child Sexual Abuse;
- Active participation in events on child vulnerabilities, transition to adulthood and victimisation organised by Save the Children, PICUM, Missing Children Europe and CRAG.

Other activities:

- Participation in 2 international UN Conferences, hosting side events, on Terrorism and Transnational Organised Crime;
- Provided **input on UNODC Resolution 17/2025**, on Challenges, Lessons Learned and Best Practices to ensure Equal Access to Justice for all individuals;
- Council of Europe Inputs on the Guidance for CSO Participation in COE Intergovernmental Committee work;
- Input on the European Union Drugs Agency Consultation in Lisbon.

- Amplified members' voices and priorities at the EU level.
- Engagement with members for revised Victims' Rights Directive and continued monitoring of EU Victims' Legislation.
- Supported national advocacy efforts (toolkits, MPP).
- Informed on trends and developments in Brussels and through our engagement/networking with the UN.
- Visibility as part of a European leading umbrella organisation.
- Engagement with Permanent Reps in Brussels.
- Briefings.









Future look on activities Dec - May 2025

- Prepare engagement for trilogues of revised Victims' Rights Directive;
- Monitor global and EU policy developments related to victims' rights;
- In-house evidence collection and analysis of the progress done regarding the implementation of the EU Victims' Rights Strategy (2020 2025);
- Advocate for the adoption of the new EU Victims' Rights Strategy;
- Organise key stakeholder meetings with EU Institution and partner EU NGOs;
- Participation in the European Commissions' Victims' Rights Platform;
- Respond to EU Launched Public Consultations;
- Influence the new college of commissioners to focus on victims and adopt our approach on national frameworks (i.e. Safe Justice and Effective Communication);
- Develop multimedia solutions to promote policies;
- Policy Analysis based on mainstreamed specific rights;
- A memorandum supporting advocacy effort of VSE and its members to influence the EU in the post-elections phase and make victims' issues central and cross-cutting in all policy areas;
- ECHR/ECJ case law monitoring.
