Name: Recognising Signs of Child Trafficking for Sexual Purposes in the Classroom

Date: 24th September 2024

**Target Audience:** Educators, school administrators, social workers, and stakeholders involved in child protection and education, particularly those working in contexts where the risks of child trafficking are prevalent. The event is also relevant to professionals interested in improving their awareness and response strategies to combat trafficking in human beings in educational settings.

#### **Description:**

This webinar, organised under the DISRUPT project, focuses on the critical issue of child trafficking for sexual purposes within educational environments. The event aims to equip educators and related stakeholders with the necessary knowledge and tools to identify potential signs of child trafficking among students. The session will delve into risk factors, key indicators of trafficking, the methods commonly employed by traffickers, and strategies for discussing these sensitive topics with children and adolescents.

The webinar will feature two main segments: an introductory overview in English, followed by specialised break-out sessions conducted in several languages. The event will conclude with a Q&A session to engage directly with experts in the field.

### **Objectives:**


- **1. Awareness:** To raise awareness among educators and stakeholders about the risk factors and signs of child trafficking for sexual purposes.

- **4. Multilingual Approach:** To provide accessible information through break-out sessions in multiple languages, ensuring broader participation and understanding.
