## How did members benefit from your current work?

- **Promoting High-Quality Services**: Organising working group meetings on various topics, including AI, helpline standards, communication, and training, to encourage knowledge exchange and sharing of experiences among members.
- Youth Perspective: Launching the Youth Ambassador Network to foster youth participation and involvement in victim support initiatives.
- Standards and Accreditation: Developing standards and accreditation mechanisms, including finalisation of the 116 006 Helpline Standards, and providing guidance through the Centre of Excellence for organisations running or planning 116 006 helplines. These initiatives recognise and reward the quality of services provided by VSE members.
- Membership Development and Community Growth: Revising membership structures and policies, finalising the Membership Management System, conducting members' surveys, and reviewing new applications to strengthen the VSE community and ensure members benefit fully from VSE activities.







# How did members benefit from the current work on training?

### • Improved Overall Standards in the Victim-Support Field

Training raise the overall quality of practices across the sector. This creates a more effective ecosystem in which VSE members operate, improving cooperation pathways and ultimately benefiting their work with victims.

### Access to Better Tools, Knowledge, and Resources

The development of training modules, online and hybrid learning formats, professional videos, and the future Training Academy provides a growing pool of resources that members can use, reference, or learn from—whether directly involved in the training or not.

### Strengthened Cross-Border Consistency and Collaboration

Activities supporting EU networks, law-enforcement training, and capacity building contribute to more aligned approaches across countries and institutions. Members benefit from smoother collaboration with partners who increasingly share similar standards, language, and victim-centred practices.
