## Call for proposals to promote civil society organisations' awareness of, capacity building and implementation of the EU Charter of Fundamental Rights:

VSE is leading a proposal that aims to train CSOs and legal professionals on how to use the Charter in strategic litigation and how to communicate victims' rights through legal cases in criminal, administrative, civil or any other legal proceedings that might deem as appropriate conduit to a strategic result.

## Fighting Crime and Terrorism 2024 (HORIZON-CL3-2024-FCT-01) - OPEN TOPIC:

VSE is leading a proposal that aims to create an innovative citizens engagement bundle that will comprise a set of mechanisms and tools that will be integrated in a thorough participatory platform aiming to build trust among citizens, enable data acquisition, realise community engagement and further facilitate the activities of victim support organisations in collaboration with LEAs.
