VSE-led proposals

Call for proposals for action grants to support transnational projects on training of justice professionals covering civil law, criminal law or fundamental rights:

VSE led a proposal that aimed at building a knowledge and skills base for legal professionals in Bulgaria, Croatia, Greece, Lithuania and Portugal, to address the needs of victims and transform the experience of victims in legal proceedings.

Call for proposals to prevent and combat gender-based violence and violence against children:

VSE led a proposal which aims to collect an evidence base on the impact of direct cross-examination of children in court to inform the design of Psychoeducational Tools and advocate for its elimination in criminal procedures.

TSI 2025 Flagship technical support project:

VSE is leading the development of a multi-country proposal (second stage - proposal already approved) on the establishment, implementation and strengthening of a national system for victim support in Latvia and Lithuania.
