The [Victims' Rights Directive](#) (VRD) sought to address issues surrounding victimisation and created a solid foundation for victims' rights. Yet, the vast majority of victims never report a crime to the police and never seek justice, but those who do, may suffer further harm as a result. VSE's 'Model Provisions Paper' (MPP) sets out a vision for a revised VRD, based on the idea that States must adopt a comprehensive framework; one

that is designed to implement all victims' rights and to provide support to all victims.



[BeneVict](#) - Project Update



VSE is analysing the results of the research conducted in 26 EU member states to evaluate the practical and legal implementation of the Victims' Rights Directive. Moreover, the research team is developing a methodology for a Victim's Rights Index which will be used to rank member states according to their performance in the sphere of victims' rights. In addition, partners from 4 EU member states are collecting data on

the cost of victimisation which will later be analysed and presented in a report that quantifies the cost of victim support.

NEWS FROM VSE MEMBERS

CYPRUS: Since April 2023 and following a Ministerial Decision of the Deputy Ministry of Welfare, the Association for the Prevention and Handling of Violence in the Family has undertaken the operation of a program, called Sofi's House, for migrant young and underage mothers who have arrived in Cyprus as asylum seekers or victims of trafficking. Currently the program hosts 12 young women and 11 newborns and children.

SWEDEN: COVIS (court based victim and witness support service), led by Victim Support Sweden, aims to build knowledge and provide tools to establish

and deliver quality court based support services for victims and witnesses of crime and to meet the needs and rights of all victims/witnesses participating in criminal proceedings. 
