**2GETHER4VICTIMS:** On the 26th of September, the Advisory Board for 2G4V met online for the second time to discuss the project's progress and gather experts' feedback on the research report and the first drafts of the Individual Needs Assessment (INA) and Organisational Self-Assessment (OSA) tools that Women's Room and APAV have been working on, in close collaboration with the partnership.

BENEVICT: On 15 October, VSE presented key findings from project BeneVict in a webinar hosted by Spanish partner ATENIN with the title "I Jornadas sobre Victimoasistencia: De Víctima a Protagonista." The findings focused on common challenges in the practical implementation of the Victims' Rights Directive in the 26 EU Member States represented in the project. Moreover, VSE is developing a Victims Rights Index methodology and is finalising the report on the assessment of the practical implementation of the Victims' Rights Directive which will be available by the end of 2024.

**DISRUPT:** The <u>DISRUPT project</u> recently held its first-ever intensive training at the European Parliament in Brussels, bringing together law enforcement officers, prosecutors, judicial authorities, and legal practitioners from across Europe to tackle human trafficking through innovative digital means. This two-day training, held on October 16 and 17, focused on advancing the use of digital evidence in investigating and prosecuting trafficking cases, particularly those involving child victims.

# 06 - NEWS FROM VSE MEMBERS



**IRELAND:** Victim Support at Court (V-SAC) is now a fully national service, and its volunteers provide support for victims of crime in every county of the Republic of Ireland. The official opening of V-SAC's new office in Cork City completes this last phase of its national expansion.

**ALBANIA:** The Executive Director of CRCA/ECPAT Albania, Mr. Altin Hazizaj, was welcomed a meeting, with vice Prime Minister of Albania, Mrs. Belinda Balluku. The meeting was organized following CRCA Albania's effort to

NEW ZEALAND: Victim Support in New Zealand has recently wrapped up its most ambitious campaign yet, addressing a deeply rooted problem: victim blaming. The advocacy campaign addressed an enduring cultural issue highlighted in their latest research. It discovered that victim blaming has a profound impact on both victims of crime and the social fabric of New Zealand. Some research participants even said that victim blaming was worse than the crime itself.

CROATIA: White Circle Croatia highlights the Final Conference held in Zagreb entitled 'Victims' Rights: Where are we today?' as the final part of the project 'Survive, Overcome and Support Victims of Crime' - 'S.O.S. for victims', an extremely important event. It marks the culmination of a two-year project funded by the European Commission. Throughout the past few months, White Circle Croatia continuously provided social services to their users. There is a noticeable growth of as much as 30% of users seeking psychosocial support compared to last year.
