CELEBRATING OUR PAST CREATING HOPE FOR THE FUTURE The new year is upon us, what should you expect from Victim Support Europe in 2020?

From firm favourites like our victims' rights social media campaigns, we will continue pushing forward the findings of VOCIARE report that tracks how EU Member States implement the Victims' Rights Directive 7 years after it was established; we will launch a new website in spring 2020; we will set the foundation for the European Centre of Expertise on

Terrorism which will operate to make sure that victims of terrorism across Europe receive the support and recognition they deserve; plus so much more.

This year Victim Support Europe celebrates its 30th anniversary. We look forward to a new decade for the advancement of victims' rights in all Member States. Throughout 2020, we will be celebrating the many people — victims-survivors, frontline support workers, victims' rights defenders, civil society actors, authorities, funders, and community members — who have brought VSE's mission to life for the last 30 years.

Our priorities for 2020 will cover such issues as terrorism, disability, cyber and hate crimes, gender equality, enforcement of victims' rights across the EU and the use of new technologies in communicating victims rights to name just a few. As the EU's leading independent hub of victims' rights excellence, Victim Support Europe sees these strands to actively engage in.

Worryingly, some governments across the EU are not pursuing their victims' rights commitments. This brings us to the need to make adamant demands of the politicians and governments for more urgent action.

In order to identify the most toughest victims' rights challenges Europe faces, VSE together with its partners carried out a two-year VOCIARE Project across the 26 EU Member States. Ultimately, these findings can stand as a basis for a careful rethinking, at national and EU-level, of how are victims' rights being enacted (or not) and what can be done to improve their standing. With concrete recommendations for each Member State, it promises to provide rich input to national governments, European Commission and VSE, as it reshapes our list of actions to advance the rights of crime victims across the EU.

The founding of Victim Support Europe was a process, not a moment. It took years to establish many national support services and projects that we are now associated with. The EU Victims' Rights Directive, the major EU law on the rights of victims of crime, wasn't established from scratch and arose from other policy initiatives and documents. Member States committed to victims rights 35 years ago and repeatedly:

- Council of Europe Recommendations 1985 and 2006
- UN Declaration of Basic Principles 1985
- EU Framework Decision on standing of victims 2001
- EU Victims Directive 2012 (in force 2015)

30 years is a quite a time. There is much to celebrate. There is much to be done. Let's remember the lessons we can draw from more than 3 decades of our collaborative work. The alliance of our 58 member organisations, which help more than 2 million victims of crime a year, does fundamentally influence the enforcement of victims' rights across the EU. On this 30th anniversary, let's remember that we can't connect the dots looking forward, we can only connect them looking backwards.

The European Day of Victims of Crime aims to mobilise people to speak up and take action against crimes, as well as show solidarity and support for the victims of crimes.


The Action Week #OneVoiceOneCause mobilises the national campaigns and European partners of the victim support community in joint activities on raising awareness on victims' rights.
