Did you know?



Marital rape, the act of sexual intercourse without the consent of one spouse, is a crime

Verbal abuse, perpetrated by one family member to another is considered domestic violence and is a crime



Hate speech, threatening, abusive or insulting comments on social media, is a crime

Using threatening, abusive or insulting words or behaviour with intent to stir up hatred, is a crime



Domestic violence, rape and crimes affecting public order can be reported by witnesses or bystanders

You are a victim of crime, if you are a family member of a person whose death was directly caused by a criminal offence



Services

Victim Support Malta runs three services. VSM's core service offers counselling, psychotherapy and information about rights and legal procedures to all victims of generic crime such as domestic violence, burglary, arson, cybercrime, sextortion, revenge porn, harassment, stalking and hate crime to mention a few. On average, VSM takes on approximately 200 new clients every year.

VSM also provides a Care for Victims of Sexual Assault service (CVSA), in collaboration with the Ministry for the Family, Children's Rights and Social Solidarity. The service provides holistic care to individuals who have suffered sexual assault and rape.

The services provided by VSM include the provision of emotional support to assist victims in overcoming the trauma following a crime; legal information pertaining to the relative criminal procedures, the victims' right to request compensation and to access forms of protection provided by law; and practical assistance such as liaison with the police.

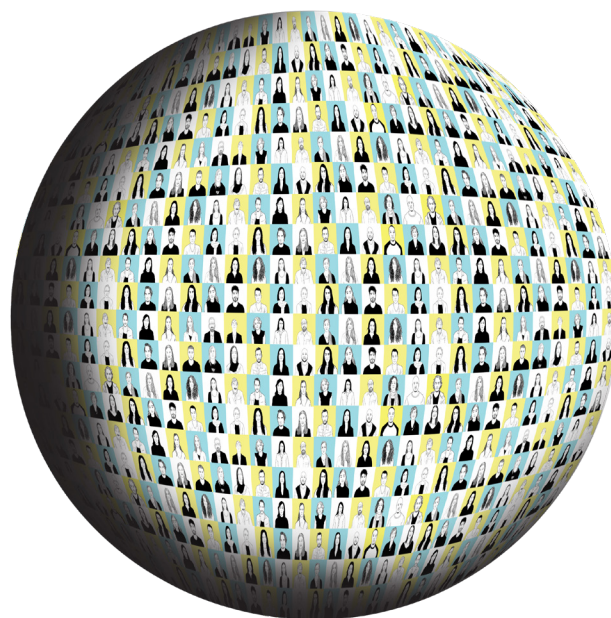
